### **Principles**

St Monica's Primary School has a responsibility to create nurturing school environments where children and young people are respected, their voices are heard and they are safe and feel safe.

#### **Policy Commitments**

- All children have the right to feel and be safe
- Our school teaches children skills to understand and maintain their personal safety and wellbeing
- Our school listens to children, taking their view seriously, and addressing any concerns that they raise with us
- Our school will communicate honestly and openly with parents and carers about the wellbeing and safety of their children
- Our school will listen to the views of staff, children and our community about our child-safety practice, policy and procedures
- We will listen to all concerns voiced about keeping children and young people safe from harm





### **Expectation for our school staff**

- All adults in our school have a responsibility to care for children, to promote wellbeing and keep them safe
- Our school has a Code of Conduct for all adults. It states the expectations for adults working, volunteering or visiting our school.



#### **Student participation**



Our School actively encourages all students to express their views and feel comfortable about giving voice to the things that are important to them

### **Reporting and Responding**

Our School respects children's views and their privacy. If a child has a concern and reports this to a staff member they will take the appropriate action. All staff have a Child Safe Folder that has all the policies and guidance on how to respond.





#### Recruitment



Our school follows the Catholic Education Commision of Victoria (CEVC) guidelines to employ staff.

#### **Professional Learning for Staff**

Staff, volunteers and visitors to St Monica's Primary School have an induction so they can understand their responsibility to Child Safety.

Staff, volunteers and visitors will have regular training updates to make sure they understand the Government requirements for Child Safety.



### **Risk Management**

All staff are responsible for identifying and managing risks to student safety All staff have a Child Safe Folder with policies and guidance. Children must let an adult know if they see a risk.
