

St. Monica's Primary School Fees 2025

Family Fee

The 2025 Family Fee for St Monica's Primary School is \$2,192 per year. This one fee is applicable no matter how many children you have attending the one school. Please refer to the table below for payment frequency options.

Student Fee

The student fee for primary students reflects the cost of the learning and teaching program at different year levels. A table showing payment across each year level is included below.

Example:

If you have a student in Foundation and Year 3, your school fees would be

\$2,192.00 Family Fee
 + \$735.00 Foundation Fee
 + \$1,285.00 Year 3 Fee
 = \$4,212.00 Total for 2025

Billing

Invoices will be prepared and sent at the commencement of the 2025 school year. A Direct Debit form can be downloaded from the school website.

Your obligation

As part of your enrolment contract, you have legally agreed to a financial commitment and are legally bound to pay fees and charges for your enrolled child.

The following payment frequencies are available for your convenience:

- Fortnightly / Weekly – Direct Debit via bank account or credit card (Fridays)
- Monthly – from February to October (9 payments) – 15th of each month
- Triannual – Due in March, June and September (3 payments) – 15th of each month
- Annual – 31st March (1 payment)

Payment Arrangements

All new families or families without a payment arrangement in place must complete the "Direct Debit Authority" by the end of the 2024 school year and scheduled payments will be set up by the school to pay either by Credit Card, or Direct Deposit.

Direct Debits will be set up at the start of the year for weekly (36 weeks), fortnightly (18 fortnights), monthly (9 months), quarterly (3 payments) or yearly payment options.

CentrePay is available for Centrelink recipients to have payments deducted from their benefits.

Any other payment methods not mentioned above must be discussed with the school Finance Officer and are subject to approval.

All existing direct debit arrangements will continue unless notice is given to the school. For continuing direct debit arrangements, amounts will be varied to reflect the 2025 fees.

Camps

Participation in the Year 3, 4, 5 and 6 camps are compulsory and a requisite to the school curriculum, fee refunds will not apply. In extenuating circumstances, camp fees may be refunded if approved by the school Finance Officer no later than 60 days prior to the scheduled camp date. Students who are unwell and can't attend camps are still required to pay for the costs incurred by the camp provider as schools outlay a set amount to fund the provision of camps in their annual budget based on the number of students in that year level.

Fee Concessions for 2025

Catholic Education Sandhurst wishes to inform Primary School Families holding eligible (means tested) health care cards that they are eligible for a significant reduction in school fees for the upcoming 2025 year.

The discount will be applied automatically upon supplying the following (attached)

- School's Application Form(attached)
- School's Direct Debit Authority Service Agreement or copy of the CentrePay application(attached)
- A copy of the eligible means tested HCC or PCC
- Camps, Sports & Excursions Fund (CSEF) application form (attached)

Applications should be lodged prior to the end of the 2024 school year so that they can be assessed and direct debit and CentrePay arrangements can be initiated for the following year.


Applicants will receive written notification of the outcome. Any applications for fee concession will only be valid for 2025.
